Accommodation for Minors

At Limehouse Library Hotel London, we prioritise the safety and well-being of all our guests, including minors under the age of 18. To ensure their comfort and security during their stay, we only accept minors to stay at our hotel with their parent or legal guardian and we require specific arrangements if a minor will be accompanied by an adult who is neither their parent nor legal guardian.

Proof of Relationship – Differing Last Names:

If a parent or legal guardian has a different last name from the minor they are travelling with, proof of relationship is required.

Acceptable documents include:

- Birth certificate
- Adoption papers
- Court-issued guardianship documents
- Parental responsibility order
- Legal custody documents
- Notarised consent letter from the other parent (if applicable)
- Government-issued identification listing both names and relationship (where available)You must submit <u>one</u> of the above documents at the time of booking or check-in.

Accompanied Minors Policy:

Minors under the age of 18 must be accompanied either by a parent or legal guardian during their stay at Limehouse Library Hotel London. However, if in the event a minor will be staying with an adult who is neither their parent nor legal guardian, the following steps must be taken:

- 1. Written Consent by Parent and / or Legal Guardian: The parent or legal guardian of the minor must complete the Parental Consent Form, providing details about the minor's stay with the accompanied adult.
- 1. **Submission of Accompanying Adults ID Document:** Along with the Parental Consent Form, the accompanying adult must submit a scan or copy of the parent / legal guardian's ID document to verify their relationship with the minor.

- 5. I acknowledge that my child will be subject to all hotel policies and regulations, and I will ensure that my child complies with them.
- 6. I agree to provide Limehouse Library Hotel with accurate emergency contact information and any relevant medical or behavioural information about my child to assist hotel staff in providing appropriate care if necessary.

- 7. I will attach a copy of my valid identification (e.g., driver's license, passport) to this consent form to verify my identity.
- 8. I understand that providing false information or fraudulent documents may result in legal action and immediate termination of my child's stay at Limehouse Library Hotel.
